Motion: The conference planning committee proposes the rates listed below. The committee recognizes that these rates are relatively low. The primary rationale for offering these rates is to encourage library professionals to return to a primarily in-person event. If approved, these rates will be marketed as encouraging members to become reacquainted with the organization and as recognizing the budgetary restrictions many libraries are facing. The preliminary conference budget and estimates indicate that these rates would cover the expenses of the conference and realize a profit that would be sufficient for the needs of the organization at this time. Proposed rates: Full conference + virtual: \$100 for members, \$125 for non-members Access to all virtual events + all in-person events, records, and virtual posters Virtual Only: \$25 for members, \$35 for non-members Access to virtual only events + access to records of select events (e.g. keynotes subject to speaker consent) One day in-person + virtual: \$50 for members, \$65 for non-members Student (full conference + virtual): \$25 Presenters: \$75 for members, \$100 for non-members Pre-conference: \$10 Additional notes: * There is not a presenter discount for virtual, but virtual presenters get a discount on the full conference. * Access to content on Whova will be available for six months after the conference. * Virtual content will not be duplicated in-person and is only available virtually. * In order to attend pre-conference, attendees must register for at least one day of in-person attendance. Events will be for a half-day and each workshop is charged separately. Presenter discounts apply to all presenters: virtual (presenter or poster); poster; and in-person
