This introduction to BIBFRAME and Linked Data is an update of the presentation offered last fall at NCLA 2015. We will look at new developments, such as examples of libraries who have gone "live" with linked data and advances in web visibility, and review areas that continue to be challenges. In addition, this presentation will provide a conceptual overview of linked data and BIBFRAME, plus a summary of resources and best practices to help you understand and prepare for the future of bibliographic data exchange. Audience takeaways will include an update on current initiatives, a list of tools used, and sources for further information. A question and answer session will promote the exchange of questions and ideas from the audience as we explore the upcoming changes in bibliographic and metadata exchange.

Supporting Research Data: Public and Technical Services Collaboration

How can academic libraries concentrate their research data management efforts to best meet the needs of their campuses while also maximizing limited resources? At UNCG, librarians collaborate across departments to support targeted research data management needs on campus. This collaborative effort builds on the strengths of an existing multi-school institutional repository system (NC DOCKS: <http://libres.uncg.edu/ir/uncg/>) and a long running outreach and instruction program for secondary data discovery.

This presentation will discuss the scope and component pieces of the University Libraries' data management services. We will present on the development of our service model and various associated activities, including support for data management planning, a series of workshops for graduate students created in collaboration with our Institutional Review Board, outreach and training efforts, and institutional repository integration.

Presenters will address specific roles, workflows, challenges, and lessons learned, and will provide perspectives from both public and technical services. Throughout the presentation we will encourage participants to consider points for collaboration within their institutions to support research data management.

In a State of Convergence: The Collaborative Role of Cataloging in Digitization Projects

Archives and Special Collections at North Carolina Agricultural and Technical State University's F. D. Bluford Library organizes documents or records relating to the activities of the university, the provenance of artifacts, graduate theses and dissertations of its students, and other special collections. The Cataloging Department generally describes a work, performs subject analysis, name authority creation, and classification to systematically organize books and other materials for collections. At one point in time, these two departments worked almost exclusive of each other—one working with monographs and the other with archival materials. However, with a library goal to increase accessibility to unique collections through digitization, the activities of these two departments have converged. This presentation will discuss collaboration activities between the two departments to make archival digital collections discoverable and accessible to users.

OERs and Alt-Texts in Tech Services: How to Get the Job Done

Libraries are being called upon to do more with OERs (Open Educational Resources) and Alt-Texts. From locating them to cataloging them, technical service departments need to know how to work with them. It will also discuss an LSTA grant shared by both institutions that is helping them save students money with OERs and Alt-Texts.
